FREEDOM OF INFORMATION ACT NOTICE

Dear Ms. Walsh:

The Michigan Department of State acknowledges receipt of your letter dated April 12, 2016 in which you submitted a request for public records pursuant to the Freedom of Information Act (FOIA), 1976 PA 442, MCL 15.231 et.seq. Your request was received by the Department on April 27, 2016.

One of your requests could be granted as there is no cost for the response. The current fee to reinstate a driver's license suspended under MCL 333.7408a is \$125.00.

It is estimated that the other requests you made will cost the department \$1559.82 to query and compile the information. The cost will be in excess of \$50.00. Please pay the amount of \$779.91. This amount is one half of the cost to fulfill your request. Additionally, you requested an estimate for the cost of each request. The second and third requests are contingent upon the data from the first request. Due to the need to query the entire Michigan driving population and subdivide the drivers as they relate to requests one and two, the cost will be the same. Gathering the data for the first request is more involved and requires a lot of labor and CPU time. This query is the most costly. FOIA authorizes the Department to charge for mailing costs, copying, searching, reviewing, deleting and separating exempt information. Upon the receipt of your nonrefundable deposit, the Department will complete the processing of your request. The Department will notify you in writing when completed and mail the records upon receipt of your final payment of \$779.91.

Your request for a waiver of fees due to your non-profit status is denied as your agency does not meet the criteria prescribed in section 4 of the FOIA, MCL 15.240. Under section 10 of the FOIA, MCL 15.240, the Department is obligated to inform you that you may do the following:

1. Appeal this decision in writing to the Secretary of State's designee:

The writing must specifically state the word "appeal" and must identify the reason or reasons you believe the denial should be reversed. The department must respond to your appeal within 10 business days of its receipt. Under unusual circumstances, the time for a response may be extended by 10 business days.

2. File an action in the Court of Claims within 180 days after the date of the final determination to deny your request. If you prevail in such an action, the court is to award reasonable attorney fees, costs, disbursements and possible damages.

Also enclosed is a Freedom of Information Act Detailed Itemization of Fees form. The form outlines the cost of providing the requested information. Please submit your check or money order in the amount of \$779.91 made payable to the State of Michigan — Cashier Unit, 7064 Crowner Drive, Lansing, MI 48918. To ensure proper credit, please enclose a copy of this letter with your payment in the enclosed envelope.
