Dear Mr. Kimmel:

Washtenaw County wishes to amend the commissary contract with your agency. Corporation Counsel has indicated that this amendment could be accomplished by a letter signed by both of us. If this amendment is agreeable to you, please sign and return all copies of this letter. You will receive an executed copy of this letter upon completion.

Accordingly, I hereby amend the Service Contract between Washtenaw County and Aramark Correctional Services Inc dated May 1, 2002 follows:

Amend ARTICLE 3 Financial Arrangements (Commissions) as follows:

“As of 4/3/08 ARAMARK shall pay to the SHERIFF a commission in the amount equal to 23.5%. ARAMARK will also provide a new inmate commissary menu as agreed. Once the new commissary menu is implemented, the SHERIFF will receive additional 2.5% commission from ARAMARK, bringing the commission total to 26%.” ARAMARK will not retain access to inmate funds and will work through the Sheriff’s Business Manager to verify inmate accounts.”

Amend ARTICLE V- TERM to extend the contract as follows:

“This contract shall be extended for an additional four (4) months commencing 4/1/09 through 7/2/09 with the following provisions:


- An immediate audit of the current program, including inventory
- The implementation of a separate billing system

Thereafter, the SHERIFF may extend this Agreement for additional periods of twelve (12) months each, provided that the services to be provided, and the commissions payable to the SHERIFF, for the extension period, have been mutually agreed upon by the SHERIFF and ARAMARK.”

All other terms and conditions remain the same as in the original contract.
