**SUBJECT: DEPARTMENT OF CORRECTIONS – CONTRACT AWARD TO KEEFE  
COMMISSARY NETWORK FOR THE OPERATION OF THE ESSEX COUNTY  
COMMISSARY AT THE CORRECTIONAL FACILITY – EXERCISING TWO YEAR  
CONTRACT OPTION – REVENUE TO THE COUNTY**

**WHEREAS,** the County of Essex has a need for a vendor to provide for the Operation of the Essex County Commissary at the Correctional Facility (the “Services”); and

**WHEREAS,** the Board of Chosen Freeholders awarded a two (2) year contract for the Services to Keefe Commissary Network with a two year contract option, via Resolution #2013-00305 (Bid # 13-017); and

**WHEREAS,** the County’s Department of Correctional Services through the Office of Purchasing recommends the Board of Chosen Freeholders exercise its two (2) year option to the contract for the period May 1, 2015 to April 30, 2017 with Keefe Commissary Network; and


**WHEREAS,** it has been determined that the vendor has been performing its services in an effective and efficient manner; and

**WHEREAS,** the New Jersey Public Contracts Law (N.J.S.A. 40a: 11-1 et. seq.) requires that the Board of Chosen Freeholders by resolution approve the awarding of a contract for the provision or performance of any goods or services, the cost of which in the aggregate exceed the statutory bidding threshold; now, therefore, be it.

**RESOLVED**, by the Essex County Board of Chosen Freeholders:

1. That the award of the Contract for the Services at a Revenue to the County of 48.2% of the Commissary Price List exercising its two (2) year option to the contract period May 1, 2015 to April 30, 2017 to Keefe Commissary Network, in accordance with the recommendation of the County's Office of Purchasing, be and hereby is approved, and that the County Administrator be and it hereby is authorized to enter into and execute said contract as aforesaid together with such other documents incident thereto as may be necessary.
  
2. That the Clerk of the Board of Chosen Freeholders forward two (2) certified copies of this resolution and agreement to the Office of Purchasing and one copy to the Department of Corrections.

**Introduction:**

On April 10, 2013 the Board of Chosen Freeholders via Resolution #R-2013-00305, awarded a contract to Keefe Commissary Network, 301 Mill Road, Edison, New Jersey 08837 to provide Commissary services to the Essex County Correctional facility. In accordance with the Local Public Contract Law (N.J.S.A. 40A:11-1 et seq.), the County's Office of Purchasing advertised for bids. In response thereto two (2) bids were received from twenty-two (22) potential vendors who received specifications. Twenty-one (21) vendors download specifications from the Purchasing website and one (1) vendor requested bid per Newspaper advertisement. One (1) vendor was rejected for alternating the price page. This contract is awarded to the vendor by the highest percentage commission to the County Contract Period: May 1, 2015 through April 30, 2017. The Department of Corrections has requested to exercise the two (2) year extension.

The bid addresses the Correctional Facilities need to provide commissary sales to the inmates at the jail.

There is no state contract for this commodity, therefore we had to bid it out.






