CONTRACT AMENDMENT

CONTRACT NAME: INMATE TELEPHONE AND VIDEO

AMENDMENT NUMBER: 12

This amendment is made to Inmate Telephone and Video Visitation (Contract) between the State of North Dakota, acting through its Information Technology Department in cooperation with the Office of Management and Budget State Procurement Office (STATE), and Securus Technologies, LLC (CONTRACTOR).

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

WHEREAS, CONTRACTOR and the Dakota Women's Correctional and Rehabilitation Center were parties to a Master Services Agreement dated November 1, 2017; and

WHEREAS, that Master Services Agreement will be terminated and the services provided by CONTRACTOR under said agreement will be incorporated into this Amendment 12 to the Contract;

NOW THEREFORE; the parties agree to amend the Contract as follows:

Scope of Work

Contract Section 3, Scope of Work. The scope of work is hereby amended as follows:

In addition to the facilities listed in the Contract the CONTRACTOR will provide the services at the following facilities:

- Dakota Women's Correctional and Rehabilitation Center, 440 McKenzie Street, New England, ND 58647
- North Dakota Youth Correctional Center identified in Contract Amendment 8 is hereby renamed to theHeart River Correctional Center, 701 16th Ave SW, Mandan, ND 58554
 - The North Dakota Youth Correctional Center or any housing units located on the grounds of the North Dakota Youth Correctional Center located at 701 16th Ave SW, Mandan, ND 58647, may be offered services by the CONTRACTOR upon mutual writtenagreement by the STATE and CONTRACTOR.

Commission Rates:

The Dakota Women's Correctional and Rehabilitation Center will follow the STATE Commission Rates as stated in the Contract, Exhibit B Compensation Details, which is equitable to the previous contract between the CONTRACTOR and DakotaWomen's Correctional and Rehabilitation Center.

The CONTRACTOR will provide two commission payments per commission cycle. One commission payment will be remitted to the Dakota Women's Correctional and Rehabilitation Center, which will be \$350 for the billing cycle. The remaining commission amount, minus \$1600 for the Digital Mail Center costs, identified in Contract Amendment 6, will be remitted to the STATE. In any given month, in the event the commissions earned are less than such costs, the STATE may be sent an invoice for the remaining amount.

All other terms of the Contract remain in effect. This Contract Amendment is not effective until fully executed by all parties.
