- 1. The end date for the Initial Term described in the "Agreement Term" provision on Page 13 of Contract 542145 (and then modified by Amendment No. 2) is changed to the 6th day of August 2020.
- 2. The number of years under the "Option to Extend" provision set forth on Page 13 of Contract 542145 (and then modified by Amendment No. 2) is changed from 5 increments of 1 year each to 2 increments of 1 year each, for a total of 2 years.
- 3. Contractor will deploy 120 S-phones and 5 mobile carts within 120 days of the Effective Date.
- 4. Exhibit C is hereby revised to reflect the following new calling rate of \$0.33 per minute for all calls except interstate calls. Interstate calls will be billed at \$0.25 per minute for collect calls and \$0.21 per minute for calls made using debit and prepaid calling accounts.
