

AFFIDAVIT

I, the undersigned James B. Holliday, declare the following statements to be true and correct to the best of knowledge and belief.

1. During September, 1975 I was sentenced to imprisonment for one-to-two years pursuant to a conviction and probation violation in Somerset County, PA.
2. I was subsequently committed to the Pa. Bureau of Corrections Diagnostic & Classification Center in Pittsburgh, PA where I was assigned Bureau of Corrections ID No. Y-2233.
3. During November, 1975 I was transferred to the State Correctional Institution at Huntingdon, a Bureau of Corrections facility located in Huntingdon County, Pennsylvania.
4. On September 11, 1976 I was released from imprisonment in that institution because I had served my maximum sentence.
5. Pursuant to that "release" I was escorted to the Huntingdon, Pennsylvania, train station by a SCI-Huntingdon correctional officer.
6. Upon my arrival at the train station, I attempted to get out of the car at which time the prison officer told me he could not let me out, that he had to remain with me and keep me under surveillance to ensure that I actually boarded the train to depart from Huntingdon and that if I did not obey he would have to call the prison which in turn would notify the Huntingdon police to escort me out of town or that I could be arrested.
7. Actions of SCI-Huntingdon personnel made it clear that I was not welcome to remain in Huntingdon County and that despite having served my entire sentence some action would be taken against me if I attempted to get out of the car and go on my own.
8. I was convicted of another offense in 1979. I then served six years of that sentence before again being paroled from SCI-Huntingdon. I was subsequently returned to prison as a parole violator and reparaoled as follows:
  - a. recommitted to and reparaoled from SCI-Cresson on December 22, 1987;
  - b. recommitted to and reparaoled from SCI-Cresson on January 10, 1990;
  - c. recommitted to and reparaoled from SCI-Cresson on August 4, 1994;
  - d. recommitted to and reparaoled from SCI-Cresson on May 1, 2000; and,
  - e. recommitted to and released from SCI-Camp Hill on February 26, 2001.
9. For each release from SCI-Cresson described in paragraph 8, I was escorted to Altoona to take a Greyhound bus to Johnstown, PA; for the release from SCI-Camp Hill, I was escorted to Harrisburg to take a bus to Johnstown. In each instance, the escorting corrections officer stayed with me to ensure I boarded the bus and left the area.
